### Who

### When

This 6-week program (12 sessions) is held Mondays and Wednesdays from 4:00-6:00 p.m., between July 9 and August 15. Each session will be held outside RAIN OR SHINE.

### Transportation

Bus transportation, at no cost to you, is an option from Riverside Apartments in Peterborough. If your child will need transportation to and from the farm, please tell us on the registration form and complete the transportation waiver on the back of the form, *including the child’s signature*.

Children will be picked up from the bus stop at Riverside Apartments at approximately 3:30 p.m. and brought back at approximately 6:30 p.m.

### What to Bring

Snacks and water are included. Please have your child put on sunscreen and insect repellent before arriving each day and come dressed for the weather. Activities are held RAIN or SHINE.

### Our Staff & Volunteers

Our experienced educators enjoy sharing their love of gardening, farming, and the outdoors. All staff and volunteers are state background checked, and staff has CPR/First Aid training. Together, the staff and volunteers provide a supportive environment where there is at least one adult for every five kids.

## TRANSPORTATION WAIVER FORM

\*\*\* IF YOUR CHILD REQUIRES TRANSPORTATION TO AND FROM THIS PROGRAM, THE TRANSPORTATION WAIVER ALSO NEEDS TO BE SIGNED \*\*\*

I give permission for my child/charge to be transported in a hired bus operated by a qualified driver to and from Four Winds Farm in Peterborough, N.H., to participate in the Kids Connect! program, taking place **every Monday and Wednesday from July 9 to August 15**. I understand that my child/charge is expected to follow all applicable laws regarding riding in a motor vehicle and is expected to follow the directions provided by the driver and/or other adults.

I have read, understand, and discussed with my child/charge that:

- (1) s/he will be traveling in a motor vehicle driven by an adult and s/he is to wear her/his safety-belt while traveling;
- (2) s/he is expected to respect the vehicles s/he rides in and the people s/he travels with during the trip;
- (3) s/he is to remain in her/his seat and not be disruptive to the driver of the vehicle; and
- (4) the Kids Connect! staff reserves the right to discontinue transportation privileges or even attendance in the program if her/his behavior proves a disruption to or a safety issue to the rest of the students.

I understand that my child/charge is not required to participate in this activity, but I grant permission for her/him to do so, despite the possible risks. I recognize that by participating in this activity, as with any activity involving motor vehicle transportation, my child/charge may risk personal injury or permanent loss. I hereby attest and verify that I have been advised of the potential risks, that I have full knowledge of the risks involved in this activity, and that I assume any expenses that may be incurred in the event of an accident, illness, or other incapacity, regardless of whether I have authorized such expenses.
